## Minutes from Regular Council Meeting September 19, 2011

**Administrator** updated Council water damage that occurred over the weekend of September 16<sup>th</sup>, 2011. The supply line on the toilet blew and sprayed water all through the bathroom, back hallway and towards the vault. Running water was first noticed on Sunday, September 18<sup>th</sup> and we're unable to ascertain when it first began. The water damage affected the phone line and as a result the Village Office phone is not working. Administrator will contact SGI to make a claim and begin cleanup activities. The toilet was repaired on Sunday, September 18<sup>th</sup> by the Foreman.

Council expressed a concern regarding the change to the credit union's hours of operation. The new hours are not as convenient and residents will have difficulty commuting from Regina to Sedley in time to do their banking. Branch closure as a result of reduced walk in traffic will adversely affect the community.
