- 3. Tenders must be postmarked by 4:00 PM on Friday, November 1st, 2019.
- 4. A certified cheque made payable to Village of Sedley for 5% of the amount of the tender must accompany the tender.
- 5. Highest, or any tender, not necessarily accepted.
- 6. Successful bidder will have 30 days to provide the balance of cash to complete the purchase.



- 7. The following conditions are applicable and should be taken into consideration when submitting a tender:
 - According to Village of Sedley Building Bylaw property development must be completed to a closed-in state satisfactory to Village Council by May 27, 2020.
 - Any tender offer that is accepted the offeror will be required to provide an
 additional deposit of \$10,000 and enter into a formal, binding agreement for sale on
 or before June 1st, 2019. Offerors failing to comply with providing the additional
 deposit or entering into the Agreement for Sale shall be deemed to have withdrawn
 their offer and shall forfeit their initial deposit.
