53-26 **Councillor Hofer/Strass** that the Village purchase a 2021 MI-T-M Gas Hot Pressure Washer from United Rentals at a cost of \$1,942.50 **Carried**

54-26 **Councillor Leier/Ochoski** that the Village finance the purchases of the 2017 Bobcat Model S740 Skid Steer and the 2021 MI-T-M Gas Hot Pressure Washer and that the Village apply for a new term loan from Affinity Credit Union in the amount of \$39,127.50, repayable over three (3) years at an interest rate of 4.44%. **Carried**

Councillor Milewicz declared a conflict of interest with respect to the next Agenda item due to his role in facilitating the procurement of the materials and his business being a party to the Tri-Lateral Agreement and left the meeting at 7:09 p.m.

55-26 **Councillor Strass/Ochoski** that the Village enter in a Tri-Lateral Agreement with Cargill Limited and Prairie RK Welding Ltd. to facilitate the purchase of surplus fire hydrants and associated materials from Cargill Limited in the amount of \$12,000.00. The Administrator is authorized and instructed to execute the Tri-Lateral Agreement and issue payment for the materials. **Carried**
